The company will compile a summary statement of the relevant information solicited by shareholders through solicitation for the proxy and disclose the content in the website of Securities & Futures Institute (SFI) on May 21, 2018. Shareholders can link with SFI's web address (<http://free.sfi.org.tw>) of relevant information.
- VI. The shareholder voting right could be exercised through E-Voting during the period from May 22, 2018 to June 18, 2018. Please login to the TDCC (Taiwan Depository & Clearing Corporation) website (<http://www.stockvote.com.tw>) to exercise voting rights in accordance with the online instruction.
- VII. The proxies shall be tallied and verified by the Transfer Agency Department of Capital Securities Corp.
