本業表現穩健，飯店營收成長推動毛利率提升；但因金融市場波動導致營業外損失增加，稅後由盈轉為虧損。

Our core business performance was solid this quarter. Favorable pricing and an optimized product mix contributed to an expansion in gross margin. However, this was offset by an increase in non-operating losses stemming from financial market volatility, resulting in a net loss after tax for the period.

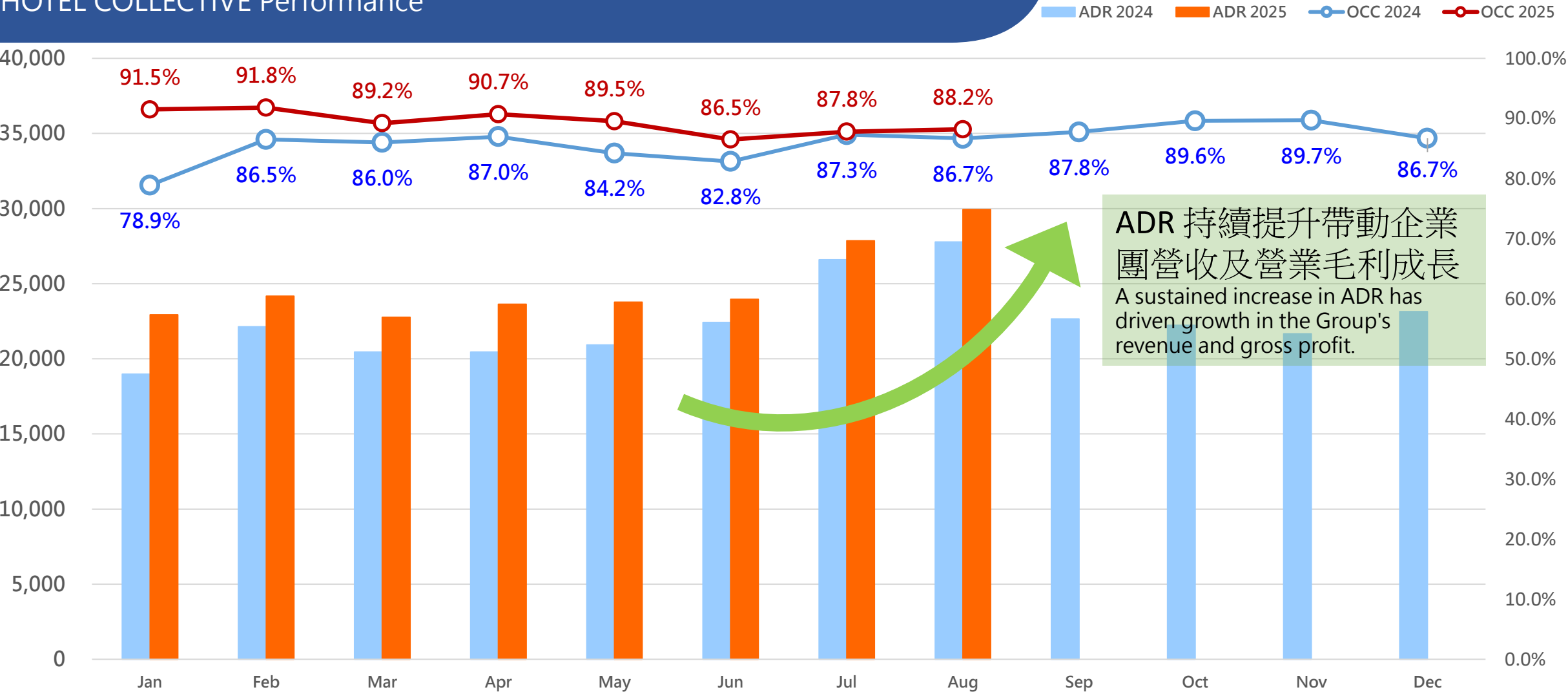

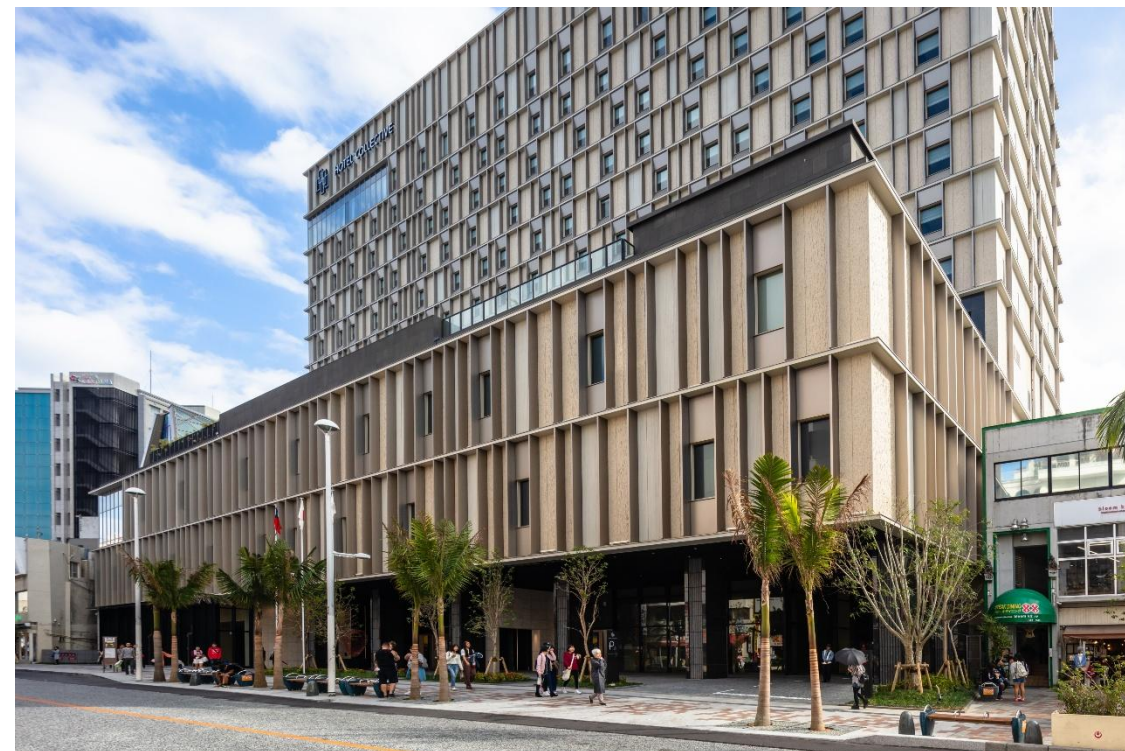
